Springvale Lions Baseball Club Internet /Wifi usage policy

The Springvale Lions Baseball Club provides a guest wireless network ("KH Wearne Reserve") for short-term access that is accessible to guests with compatible wireless devices.

This is an unencrypted wireless service. Only current guests of Springvale Lions Baseball Club may use this service. By accessing or using this service, you represent that you are currently a guest of the club and acknowledge that you have read all of the terms and conditions of this agreement, understand them, and agree to be legally bound by them.

Acceptance of Terms and Conditions of Use

By accessing the internet and or connecting to the WiFi network 'KH Wearne Reserve' you represent that:

You have read, understand and agree to the terms of this agreement

If you do not agree to the terms of this Agreement you may not use the service. Your acceptance of the Agreement by accessing the service has the same effect as if you had actually signed the Agreement. The effective date of this Agreement is the date that you accessed the service.

Description of Wi-Fi System/Service Availability

Access points may not be available in all areas of the club, and may not always be operational. The guest wireless network may be subject to periodic maintenance, unforeseen downtime, and limited availability.

Guest wireless access is provided as a free service on an "as is" basis with no guarantee of service.

Access to Internet

You acknowledge that if you access the Internet you may receive or be exposed to content, goods or services which you consider to be improper, inaccurate, misleading, defamatory, obscene or otherwise offensive. You agree that Springvale Lions Baseball Club is not liable for any action or inaction with respect to any such content on the Internet accessible through the service.

Your Responsibilities

Use of Springvale Lions Baseball Club WiFi is undertaken at the user's own risk.

You must (1) provide all equipment (including computer hardware and software, wireless network cards, etc.) to connect to the WiFi, (2) comply with local, state, national and international laws and regulations, including but not limited to copyright and intellectual property rights laws. You agree to be responsible for and to bear all risk and consequences for (1) the accuracy, completeness, reliability and/or usefulness of any content available through the WiFi network and (2) all communications that you send or receive via the WiFi. Springvale Lions Baseball Club does not undertake the security of any data you send through the 'KH Wearne Reserve' network and it is your responsibility to secure such data.

Acceptable Use Policy

All users of the network must comply with this Acceptable Use Policy (AUP). This AUP is intended to prevent unacceptable uses of the club network. Springvale Lions Baseball Club does not actively monitor the use of the Wi-Fi System under normal circumstances.

For quality assurance purposes, Springvale Lions Baseball Club reserves the right to:

- Block internet services such as Peer-to-Peer and streaming video services
- Monitor usage of "KH Wearne Reserve" for quality assurance purposes
- Limit bandwidth on "KH Wearne Reserve"
- Take any additional measures deemed necessary by Springvale Lions Baseball Club in its sole discretion

Springvale Lions Baseball Club may cooperate with legal authorities and/or third parties in the investigation of any suspected or alleged crime or civil wrong. Violation of this AUP may result in the suspension or termination of your access to KH Wearne Reserve WiFi.

Fair Use

Our wifi service is intended for email, instant messaging, internet browsing and using apps, which we consider fair use. Transferring large amounts of data uses up bandwidth and may reduce the speed at which other users of the wifi service can access it. In particular, downloading very large files, streaming and using peer to peer and file sharing software require large amounts of bandwidth and data usage. If you do not restrict your usage to fair use, we reserve the right to issue a warning to you or to suspend or withdraw our wifi service from you immediately, temporarily or permanently; or we may manage your bandwidth so that it may result in reduced service speeds. In addition, we may restrict the amount of bandwidth available to very heavy users to maintain good access for our other users.

Please ensure that your device or hardware is not infected with a virus that sends out data without your knowledge.
